Mandatory Health Precautions

Addendum to Cabana/Locker License Agreement

In order to promote a safe and healthy recreational experience and environment during the Covid-19 emergency the following regulations are in effect at the Malibu Beach Park:

1. No employee who displays or reports ANY symptoms or indication of illness will be permitted to work until such symptoms are no longer present.
2. All personnel will be issued a new disposable face mask at the beginning of their shift and are required to wear this mask while on premises.
3. No park patron who displays symptoms or other indications of illness will be permitted to enter the Malibu Beach Park.
4. All Malibu Cabana and Locker users are required to wear face masks when they are unable to “social distance” and are in necessarily close contact with other people.
5. Under both New York State and CDC rules, unvaccinated people must wear masks in public settings, and must maintain 6’ distance between their party/group and other people.
6. Fully Vaccinated people are not required to wear a mask. We reserve the right to request proof of vaccination and photo ID to match vaccination card.
7. Customers whose vaccination status is “unknown” will be considered to be unvaccinated. And must follow the rules of a unvaccinated person.
8. Picnic tables, barbeque grills, cabana and locker doors, locks and interior contents should be frequently cleaned by park users with soap, water and disinfectant.
9. Park users are requested to properly dispose of refuse, cans, bottles, and masks.
10. Children’s toys and playthings should be frequently cleaned and disinfected.
11. Park patrons MUST maintain social distancing at all times. All persons should remain not less than 6 feet away from other people, with the exception of their own family members.
12. Pool towels and garments MAY NOT be hung on fences
13. The General Store may limit the number of customers who are admitted at any one time. The Pizza Shop and Ice Cream Shop lines will be “socially distanced.”
14. Maliblu will offer a streamlined menu. All orders, including alcoholic beverages will be available “to go” and will be delivered to cabanas, lockers, and beach areas, seating will be available on the patio for self-service.

We are all living under very trying conditions which have created a “new normal.” It is important that the directives of the CDC and New York Sate government be strictly followed, so that the Malibu Beach Park can operate this summer, while providing a safe and enjoyable recreational experience for the community.

It is important that Malibu Cabana and Locker users voluntarily comply with these Health Precautions, in order to protect themselves, their families and neighbors. In order to protect the Malibu community, Park users who fail to comply with these very reasonable and common-sense precautions will be subject to the immediate termination of their Cabana/Locker License Agreement.

Your signature on the Malibu Cabana/Locker Agreement is deemed to be your agreement to the terms set forth above.

We thank you for your anticipated cooperation and sincerely hope that we can all enjoy the summer at Malibu Beach Park.
